**Select Portfolio Sector Weightings\*\***



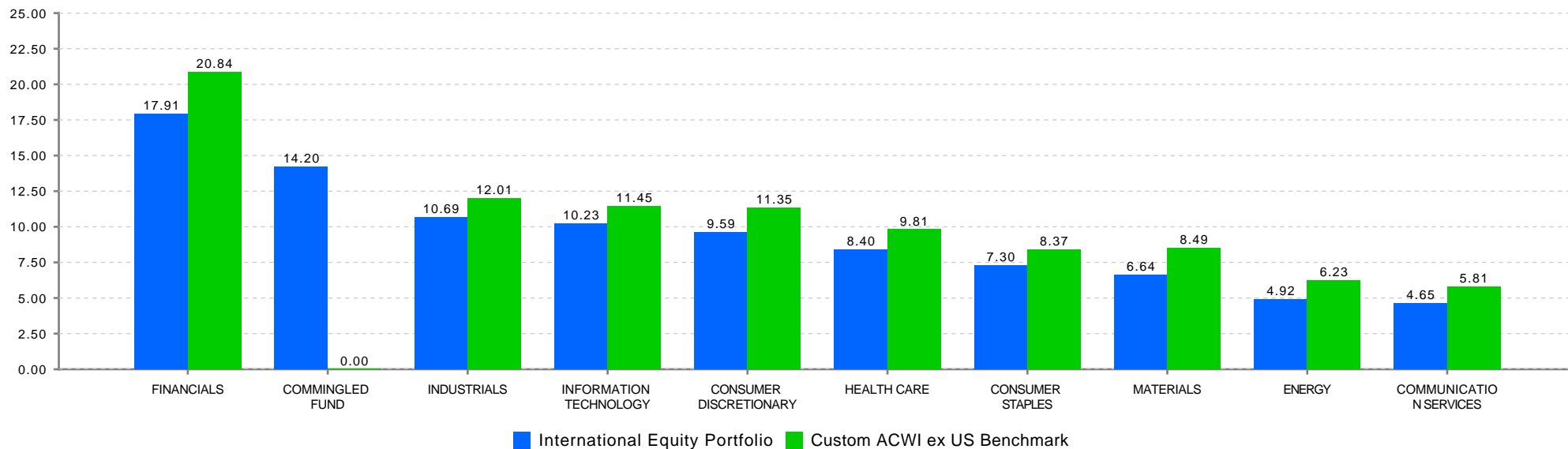

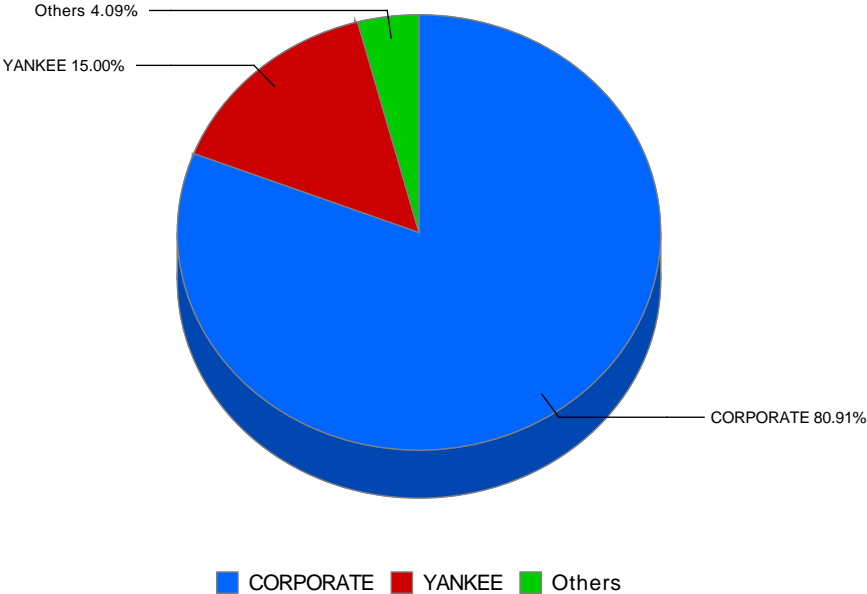

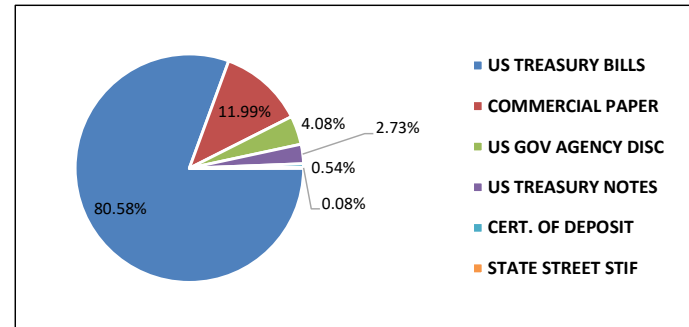
